WHEREAS, Owner wishes to adjust boundaries between two existing parcels resulting in adjusted parcel sizes of 1.42 and 57.07 acres. The adjusted 57.07-acre parcel will be enrolled in new Agricultural Land Conservation Contract No. 8328; and

WHEREAS, The rescission of existing Agricultural Land Conservation Contract Nos. 3726 and 8302 and simultaneous execution of new Agricultural Land Conservation Contract No. 8328 is to ensure the new contract reflects the acreage of the adjusted contracted parcel; and
