WHEREAS, the Department of Social Services requires \$4,325,078 to purchase furniture and audio visual equipment for the new Lease space; and

WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Organization 1120 will receive funding from the State and Federal government in the amount \$4,325,078 in FY 2018-19; and

WHEREAS, \$4,325,078 is not included in the FY 2018-19 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Welfare Advance Fund Organization 1120 as follows:




