WHEREAS, the Department of Social Services requires \$4,803,831 to purchase furniture and audio visual equipment for the new Lease space; and

WHEREAS, the Department of Social Services Fund 5610 will receive \$4,803,831 as an Operating Transfer In from the Welfare Advance Fund Organization 1120 (\$4,325,078) and the Protective Services Subaccount Organization 6210 (\$478,753); and

WHEREAS, said monies is not included in the FY 2018-19 adopted appropriations and estimated revenues of the Department of Social Services Organization 5610 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Department of Social Services Organization 5610 as follows:


