WHEREAS, the Department of Public Health will receive \$255,803 from the Centers for Disease Control and Prevention for the Innovative State and Local Public Health Strategies to Prevent and Manage Diabetes and Heart Disease and Stroke in FY 2018-19; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Public Health Org 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Public Health Org 5620 as follows:
