WHEREAS, the County of Fresno, Internal Services Department - Information
Technology Division purchased and implemented a new Environmental Health Data
Management System (AMANDA) in the fiscal year; and

WHEREAS, the costs will be financed with revenue from the Public Health Org 5620; and

WHEREAS, \$450,000 is available in the fund balance of the Public Health Fund 0080 Solid Waste Enforcement Tipping Fee Org 1158 for an Operating Transfer Out; and

WHEREAS, Public Health Org 5620 requires an Operating Transfer In of \$450,000 to meet expenditures associated with the software purchase, first year maintenance charges, and five months of deliverables; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations of the Public Health Fund 0080, Subclass 17358, Solid Waste Enforcement Tipping Fee Org 1158; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Public Health Fund 0080 Solid Waste Enforcement Tipping Fee Org 1158 as follows:
