WHEREAS, the County of Fresno has received \$123,557 from insurance reimbursement (\$6,849) and from the sale of surplus vehicles (\$116,711); and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31113229; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Sheriff-Coroner-Public Administrator ORG 31113229 as follows:
