
EVERY CHILD NEEDS A HERO, BUT ABUSED CHILDREN NEED SUPERHEROES!

Safety and security don't just happen, they are the result of collective consensus and public investment. We owe our children, the most vulnerable citizens in our society, a life free of violence and fear.- Nelson Mandela

The Children's Advocates Roundtable

The mission of the Children's Advocates Roundtable is to address current issues affecting children and families in Fresno County primarily through multi-disciplinary collaborative discussion and implementation of change within the systems of child abuse prevention, intervention and treatment.





Prenatal substance abuse has increased in Fresno County, which poses critical health risks for the developing fetus and newborn. **Debbie Harkness, MSC, LAADC** from Assessment, Training, & Research Associates assisted FCCAP in giving the first presentation in September 2017 on the effects of prenatal substance exposure for the most common drugs used such as: Nicotine, Alcohol, Marijuana, Opiates, Cocaine, and Methamphetamine. Almost all drugs are known to cross the placenta and have some effect on the fetus, both short and long-term. The goal of the presentation was to begin discussing collaboration of a county-wide prevention education campaign, such as the **049** (Zero for 9 Months) Fetal Alcohol Spectrum Disorder Awareness Day to protect infant and child health.

In response to incidents of violent and bullying behaviors in Fresno High Schools, FCCAP requested a presentation on the new restorative justice program, SHARE – Stop Hate And Respect Everyone – to help inform parents and professionals how to address and stop these abusive behaviors. Students who are both targets of bullying and engage in bullying behavior are at greater risk for both mental health and behavior problems than students who only bully or are only bullied. Students who experience bullying are at increased risk for poor school adjustment, sleep difficulties, anxiety, and depression. (CDC, 2015) Thank you to Hon. David A. Gottlieb, Superior Court Judge Fresno County & William Broomfield, Vice-President of Cen Cal Mentoring Programs for presenting the program in December 2017.





FCCAP purchased **RESILIENCE**, **The Biology of Stress & The Science of Hope**, a one-hour documentary on Adverse Childhood Experiences (ACEs) featuring **Dr. Nadine Burke Harris**, CEO and founder of the Center for Youth and Wellness in San Francisco. Other leading physicians (such as ACE Founders, Felitti and Anda), educators, and social workers talk about the effects of divorce, abuse and neglect and the birth of a new movement to treat and prevent Toxic Stress. Extremely stressful experiences in childhood can alter brain development and have lifelong effects on health and behavior. However, as experts and practitioners profiled in RESILIENCE are proving, what's predictable is preventable. They are successfully using cutting edge science to help the next generation break the cycles of adversity and disease. Through a generous donation, FCCAP was able to purchase the

documentary and present it to numerous organizations beginning in April – National Child Abuse Prevention Month. FCCAP continues to promote and offer the documentary as an opportunity for staff development and continuing education on how to effectively intervene child maltreatment.

FCCAP MISSION

In 1995, the Fresno County Board of Supervisors appointed FCCAP as the Child Abuse Prevention Council (CAPC) for Fresno County. CAPCs are legislated in the Welfare and Institutions Code section 18980 of the State of California mandating every county (58) establish a CAPC to carry out specific legislated functions within that county. CAPC's were created in response to the Legislature's findings that the prevention of child abuse requires the involvement of the entire community. Accordingly, every CAPC mission is *to coordinate community efforts to prevent and respond to child abuse and neglect, which includes these objectives:*

- •Provide a forum for interagency cooperation and coordination in the prevention, detection, treatment, and legal processing of child abuse cases.
- •Promote public awareness of the abuse and neglect of children and the resources available for intervention and treatment.
- •Encourage and facilitate training of professionals in the detection, treatment, and prevention of child abuse and neglect.
- •Recommend improvements in services to families and victims.

FCCAP BOARD & STAFF HIGHLIGHTS



SUPERHERO COUPLE SAVES ADAM'S PROJECT!

When funding for Adam's Project was lost, FCCAP Board President, Sandra Cramolini and her husband, Dr. G. Mark Cramolini saved this program through a sponsorship by The 5th Commandment Fund. Their generosity will allow FCCAP to continue providing critical health and safety information for birthing hospitals to give to parents

and their newborns.



Over 16,000 new parents will receive information on Shaken Baby Syndrome, SIDS/SUIDS, Safe Sleep (which is the #1 cause of death in infants), car seat safety, burn safety, breast feeding benefits, the effects of domestic violence, and the importance of Carry. Cuddle and Coo! Because children need love to thrive.







Everyone has a hero in their heart, but some people and organizations such as The Fansler Foundation have superhero hearts! Through an increase in funding from The Fansler Foundation, FCCAP was able to afford more staff time to address the new AB 1207 law for Mandated Reporter Training specifically for Child Care Providers which was enacted January 2018. This new law requires all childcare workers to complete an online training every two years. However, FCCAP was asked to provide this training in-person because of our reputation of providing more comprehensive trainings. Therefore, FCCAP staff revised our "regular" MDRT to meet the requirements as specified by Health and Safety Code Section 1596.8662 to meet the regulations of the new law and was approved to provide this specialized MDR Training with certification. Of the 2,536 Mandated Reporters trained by FCCAP during this funding period, 472 were certified under the AB-1207 law. Moreover, FCCAP contacted 93 local daycare centers to inform them of the new MDR Training and advise them of how and why our "in-person" training was better than online training. FCCAP is deeply grateful to The Fansler Foundation for their generosity and longstanding commitment to protecting children from abuse and neglect through educating professionals and parents because . . .
