Achievements

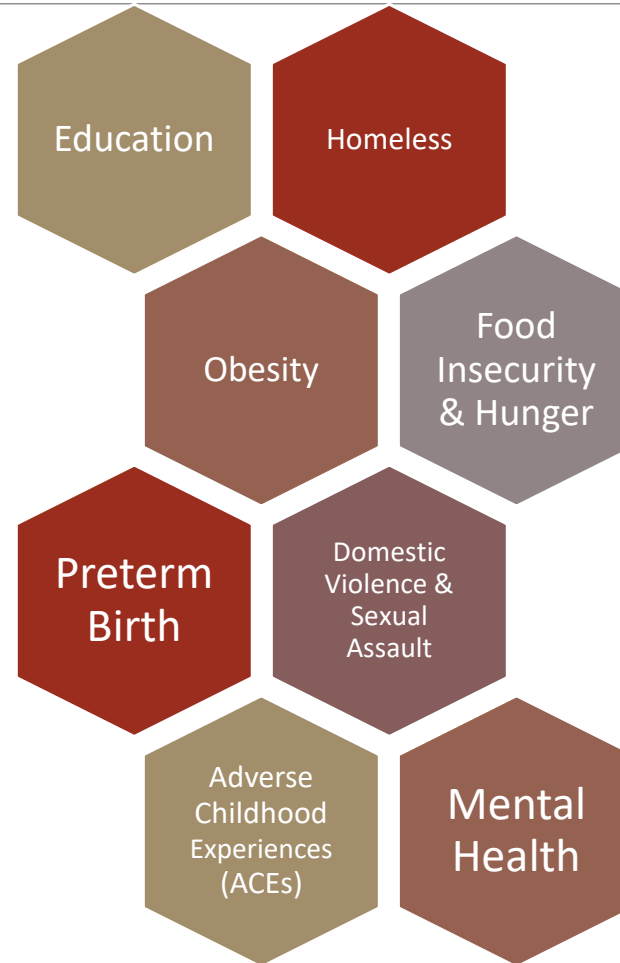
2018

Status of Women & Families in Fresno County



In 2017, Fresno Police received more than 5,000 domestic violence calls.

Dating violence among teenagers is increasing.

18% of children ages 0-17 have experiences two or more adverse experiences.

3 out of 5 people seeking assistance for homelessness are women.

Adverse Childhood Experiences (ACEs) are stressful or traumatic events that children experience before age 18, such as violence at home, neglect, abuse, or having a parent with mental illness or substance dependence.
