WHEREAS, the State has identified funding to reimburse counties for replacement of voting systems and related equipment; and

WHEREAS, additional funding is needed to pay for new voting equipment, ballot on demand systems, and vote by mail ballot drop boxes; and

WHEREAS, the State has committed to reimburse counties for replacement of voting systems and related equipment; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the County Clerk Org 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 County Clerk-Elections Org 2850 as follows:
