WHEREAS, the Department of Social Services requires \$440,220 to meet mandated assistance payments to the Aid to Families with Dependent Children-Foster Care Organization 6410; and

WHEREAS, the Protective Services Subaccount Organization 6210 requires an additional \$440,220 to meet increased costs associated with mandated assistance payments for the Aid to Families with Dependent Children-Foster Care Organization 6410; and

WHEREAS, \$440,220 is available in the fund balance of the Local Revenue Fund 0271, subclass 13030, Protective Services Subaccount Organization 6210 to fund the additional cost; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2018-19 Protective Services Subaccount Organization 6210; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Protective Services Subaccount Organization 6210 as follows:
