WHEREAS, the Aid to Refugees Organization 6615 will receive \$37,896 in State revenues to fund the increase in cost; and

WHEREAS, the \$37,896 is not included in the adopted appropriations and estimated revenues of the FY 2018-19 Aid to Refugees Organization 6615; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Aid to Refugees Organization 6615 as follows:
