WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Organization 1120 will receive \$976,637 in Federal and State funds to meet the need as an Operating Transfer Out to Aid to Families with Dependent Children Foster Care Org 6410, Aid to Adoptions Org 6415 and Aid to Refugees Org 6615 ; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Welfare Fund Organization 1120; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Welfare Advance Fund Organization 1120 as follows:


