RESOLUTION

WHEREAS, the Behavioral Health Org 5630 will have \$600,000 available for the Adult Crisis Residential Facility final expenditures of completing the facility in the amount of \$600,000; and

WHEREAS, the Adult Crisis Residential Facility Org 8851 requires \$600,000 to meet expenditures associated with project work; and

WHEREAS, \$600,000 is not included in the FY 2018-19 adopted appropriations and estimated revenues for the Adult Crisis Residential Facility Org 8851; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Adult Crisis Residential Facility Org 8851 as follows:


