WHEREAS, final expenses of completion for the Adult Crisis Residential Facility are estimated at \$600,000; and

WHEREAS, the Behavioral Health Org 5630 requires an increase in appropriations and estimated revenues to fund an Operating Transfer Out in the amount of \$600,000 to the Adult Crisis Residential Facility to fund the final cost for the facility project; and

WHEREAS, Behavioral Health Org 5630 will received funds as an Operating Transfer In from the Capital Facilities Org 1055; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for FY 2018-19 Behavioral Health Org 5630; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Behavioral Health Org 5630 as follows:


