RESOLUTION

WHEREAS, the County of Fresno, Facility Services, Organization (Org) 8935, requires an increase in appropriations in the amount of \$20,000 to allow for the payment of pest control services to facilities located throughout the County necessary to meet departmental needs and use; and

WHEREAS, said additional costs will be financed by revenue from user County Departments benefiting from said services in the amount of \$20,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2018-19 Facility Services, Org 8935; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2018-19 Facility Services, Org 8935 as follows:


