WHEREAS, Public Works and Planning – Grants Org 55122400 receives \$43,985 annually for the promotion of Beverage Recycling education; and

WHEREAS, Public Works and Planning – Grants Org 55122400 requires an additional \$11,000 to reestablish funds utilized to pay for prior year labor costs; and

WHEREAS, Public Works and Planning – Resources wishes to expend all grant funds for FY 2018-19; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2018-19 Beverage Container Recycling & Litter Reduction Grant, Org 55122400; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifth vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDER that the Auditor-Controller/Treasurer-Tax-Collector is authorized to increase the appropriations in the FY 2018-19 Public Works and Planning – Grants Org 55122400 as follows:


