

RESOLUTION NO. 2019-061

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DECLARING A VACANCY IN THE OFFICE OF COUNCILMEMBER FOR DISTRICT 2; CALLING A SPECIAL ELECTION TO BE HELD ON AUGUST 13, 2019, TO FILL THE VACANCY; AND CALLING FOR A POTENTIAL RUN-OFF ELECTION TO BE CONSOLIDATED WITH THE NOVEMBER 5, 2019 UNIFORM DISTRICT ELECTION.

WHEREAS, Councilmember Steven Brandau has served in the office of Councilmember for District 2; and

WHEREAS, Councilmember Brandau's term of office was set to expire on the first Tuesday after the first Monday in January of 2021; and

WHEREAS, Councilmember Brandau has been elected to the Fresno County Board of Supervisors; and

WHEREAS, Councilmember Brandau has submitted his resignation to the City Clerk effective at 5:00 p.m. on April 5, 2019, (attached as Exhibit "A"); and

WHEREAS, Section 305 of the Fresno City Charter requires the vacancy to be filled by special election.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. Receipt of Councilmember Steven Brandau's letter of resignation by the City Clerk, effective at 5:00 p.m. on April 5, 2019, is hereby acknowledged.
- 2. A vacancy is declared in the office of Councilmember for District 2 effective April 5, 2019.

- 3. The Council hereby requests that a Special Election be held on August 13, 2019, to fill the vacancy in the office of Councilmember for District 2 in the manner prescribed in Election Code Section 10100 et. seq.
- 4. If no candidate receives a majority of the votes cast at the Special Election, the Council requests a Special Runoff Election, consolidated with the Uniform District Election on November 5, 2019, to be held and conducted in the manner prescribed in Elections Code Section 10418.

5. This resolution shall take effect upon its adoption.
