WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5th) vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2018-19 Probation's Juvenile Justice Campus Organization 34409999 as follows:


