WHEREAS, Federal Asset Forfeiture Funds are available to fund the increased costs for a Probation K9 Unit vehicle above the normal replacement vehicle costs; and

WHEREAS, the Probation Org 3430 will receive \$42,000 as an Operating Transfer In from the Federal Asset Forfeiture Org 1142; and

WHEREAS, the Probation Org 3430 will fund an Operating Transfer Out in the amount of \$42,000 to the Internal Services Department, Fleet Services-Equipment Org 8911 for the increased costs of the vehicle; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Probation Organization 3430; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Probation Organization 3430 as follows:
