**RESOLUTION**

WHEREAS, California Public Resources Code, sections 40000 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (grants) in furtherance of the State's efforts to reduce, recycle, and reuse solid waste generated in the state thereby preserving landfill capacity, protecting public health and safety, and the environment; and

WHEREAS, funds are allocated and available from CalRecycle for grants to solid waste Local Enforcement Agencies and cities and counties with regulatory authority within the city and county government to perform solid waste enforcement/compliance and surveillance activities; and

WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures governing the application, awarding, and management of grants; and

WHEREAS, CalRecycle grant application procedures require, among other things, an applicant's governing body to authorize by resolution its approval for submittal of grant applications, and the designation by job title of the individuals authorized to execute all grant documents on behalf of the County of Fresno (County); and

WHEREAS, if awarded, the County will enter into grant agreements with CalRecycle for implementation of said grants.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors authorizes the submittal of application(s) to CalRecycle for Local Enforcement Agency Grant Program grants for which the County is eligible for FYs 2019-20 through 2023-24; and

BE IT FURTHER RESOLVED that the Chairman of the Fresno County Board of Supervisors, or designee, is hereby authorized and empowered to execute on behalf of the County all grant

documents, including but not limited to, applications, agreements, amendments and requests for payment, necessary to secure grant funds and implement the approved grant projects; and

BE IT FURTHER RESOLVED that these authorizations are effective from May 14, 2019 through May 13, 2024.


