18	to perform the City's elections functions for its general and special municipal elections; and
19	WHEREAS, in Resolution Number 2017-317 the City of Fresno consents to reimburse the
20	County Clerk/Registrar of Voters for all costs incurred by said services; and
21	WHEREAS, the City of Fresno adopted Resolution Number 2019-061 on April 4, 2019,
	respectfully, requesting a November 5, 2019 City of Fresno Special Municipal Runoff Election in
22	the event that no candidate receives a majority (50% + 1) of all the votes cast in the August 13, 2019 City of Fresno Special Municipal Election.
