WHEREAS, California Elections Code §10002, permits the governing board of a city or district to approve and execute a resolution requesting a county's board of supervisors to permit the county elections official to render services relating to the conduct of an election; and

WHEREAS, California Elections Code §10400 et. Seq., and other state laws permit consolidation of elections and sharing of election costs by cities, counties, school districts, other public districts, and other public entities by order of the County Board of Supervisors; and

WHEREAS, the Fresno County Clerk/Registrar of Voters is the county elections official in Fresno County; and

WHEREAS, on February 6, 2018, the Board of Supervisors approved the City of Fresno's request in the City's Resolution Number 2017-317 for the Fresno County Clerk/Registrar of Voters to perform the City's elections functions for its general and special municipal elections; and

WHEREAS, in Resolution Number 2017-317 the City of Fresno consents to reimburse the County Clerk/Registrar of Voters for all costs incurred by said services; and

WHEREAS, the City of Fresno adopted Resolution Number 2019-061 on April 4, 2019, respectfully, requesting a November 5, 2019 City of Fresno Special Municipal Runoff Election in the event that no candidate receives a majority (50% + 1) of all the votes cast in the August 13, 2019 City of Fresno Special Municipal Election.
