8 WHEREAS, the Inmate Welfare Organization 1500 requires additional appropriations in the  
9 amount of \$14,619 to fund an Operational Transfer Out to the Sheriff-Coroner-Public Administrator  
10 to meet expenditures associated with adding one (1) Sheriff's Health Services Manager position;  
11 and

12 WHEREAS, sufficient funds are available in the fund balance of the Inmate Welfare Fund's  
13 Special Revenue Fund 0096, Subclass 17700 to fund these expenditures; and

14 WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations of the  
15 Inmate Welfare Fund Org 1500; and

16 WHEREAS, Section 29130 of the Government Code provides for the appropriations of these  
17 funds by a four-fifths vote of the Board of Supervisors;

19 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is  
20 authorized to increase the appropriations in the FY 2018-19 Sheriff-Coroner-Public Administrator  
21 Organization 1500 as follows:
