9               WHEREAS, the County of Fresno Sheriff-Coroner Org 3111 will receive \$14,619 as  
10   Operating Transfers In from the Inmate Welfare Fund's Special Revenue Fund, 0096, Inmate  
11   Welfare Fund Org 1500 to fund the costs associated with the Sheriff's Health Services Manager  
12   position; and

13               WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and  
14   estimated revenues of the Sheriff-Coroner Organization 31114008; and

15               WHEREAS, Section 29130 of the Government Code provides for the appropriations of these  
16   funds by a four-fifths vote of the Board of Supervisors;

17               NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is  
18   authorized to increase the appropriations in the FY 2018-19 Sheriff-Coroner-Public Administrator
