

Resolution No. 19- 266

A Resolution of the Board of Supervisors of the County of Fresno Authorizing the Auditor under Government Code Section 25252 to Perform the Functions of the Board of Supervisors in Establishing, Abolishing, and Transferring Between County Funds

Whereas, Government Code section 25252 provides that the Board of Supervisors ("Board") shall establish or abolish those funds as are necessary for the proper transaction of the business of the County, and may transfer money from one fund to another, as the public interest requires; and

Whereas, Government Code section 25252 further provides that the Board may by resolution authorize the county auditor to perform one or more of those functions, and may authorize the county auditor to transfer money from one fund to another if the Board has authority over each fund; and

Whereas, in this County, the lawful function of the county auditor is currently consolidated within the Auditor-Controller/Treasurer-Tax Collector ("Auditor"); and

Whereas, the Auditor has previously performed the functions of the Board as provided in Government Code section 25252 according to annual resolutions adopted by the Board, but now has requested authority that does not expire annually, in order to improve efficiency;

Whereas, the Board wishes to authorize the Auditor to perform the functions of the Board as provided in Government Code section 25252;

The Board therefore finds, resolves, and orders as follows:

- 1. Recitals. All of the recitals listed above are true and correct.
- 2. Authorization. Effective as of July 1, 2019, the Auditor is authorized to perform the functions of the Board in establishing or abolishing those funds as are necessary for the proper transaction of the business of the County. The Auditor is further authorized to transfer money from one fund to another, as the public interest requires, if the Board has authority over each fund involved.
