NOW, THEREFORE, BE IT FURTHER RESOLVED by the Board of Supervisors of the County of Fresno acting as the governing body of the County of Fresno as follows:

 The total of the appropriations subject to limitations for the County Budget (which includes the General Fund, Special Revenue Funds, and County Service Areas) and the Water Works District Budgets under control of the Board of Supervisors were and are the amounts listed on Attachment "A".
This resolution and Attachment "A" are effective upon adoption.
