The State requires the County to ensure the availability and accessibility of an adequate number of inpatient facilities to provide medically necessary services (Welfare and Institution Code (WIC) Section 5775). The County is also required by DHCS to provide inpatient psychiatric services for indigent persons with serious mental illness with severe disabling conditions requiring mental health teatment (WIC Section 5600).
