WHEREAS, the California Census 2020 Fund 0065, Subclass 17239, Organization 1134 will receive \$71,909 from other Federal revenues to meet the need as Operating Transfer Out to Department of Social Services Organization 5610; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the California Census 2020 Organization 1134; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 California Census 2020 Organization 1134 as follows:


