16	out the provisions of the Vehicle Code, to guide traffic, and to prohibit motorists from bringing						
17	vehicles to a complete stop upon a highway, which impedes or obstructs the normal and						
18	reasonable movement of traffic, unless the stop is necessary for safe operation or in compliance						
19	with law.						
20	NOW, THEREFORE, BE IT FURTHER RESOLVED that the Fresno County Board of						
21	Supervisors directs the Director of Public Works and Planning to erect NO STOPPING signs in						
22	a manner not inconsistent with this resolution.
