

**AMENDMENT I TO AGREEMENT**

THIS AMENDMENT, hereinafter referred to as Amendment I, is made and entered into this 18th day of June, 2019, by and between the **COUNTY OF FRESNO**, a Political Subdivision of the State of California, hereinafter referred to as "COUNTY," and **STATE CENTER COMMUNITY COLLEGE DISTRICT**, a Community College District and Educational Institution, whose address is 1171 Fulton Street, Fresno, CA 93721, hereinafter referred to as "CONTRACTOR."

WHEREAS, the parties entered into that certain Agreement, identified as COUNTY Agreement No. A-15-295, effective 16th day of June, 2015, for educational counseling and training services for California Work Opportunity and Responsibility to Kids clients; and

WHEREAS, the parties desire to amend the Agreement regarding changes as stated below and restate the Agreement in its entirety.

NOW, THEREFORE, in consideration of their mutual promises, covenants and conditions, hereinafter set forth, the sufficiency of which is acknowledged, the parties agree as follows:

1. That all references in existing COUNTY Agreement No. A-15-295 to Exhibit B shall be changed to read "Revised Exhibit B-1," which is hereto and incorporated by this reference.

COUNTY and CONTRACTOR agree that this Amendment I is sufficient to amend Agreement No. A-15-295 and, that upon execution of this Amendment I, the original Agreement and this Amendment I, shall together be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in this Agreement not amended herein shall remain in full force and effect. This Amendment I shall become effective July 1, 2019.
