 - BlueDAG is a cloud-hosted software system for performing Americans with Disabilities Act evaluations of buildings and managing compliance planning. BlueDAG provides mobile digital tools for County staff to perform evaluations of buildings, roads, sidewalks, and other facilities and integrates those evaluations into a comprehensive plan to address Title II issues in an ongoing basis.

 - The total cost of the acquisition will be \$370,000. The total cost of the initial term will be \$226,000 and the cost for each of the potential renewal terms will be an additional \$72,000. This includes all software licensing for up to 10 users and an additional \$10,000 contingency for possible training or professional services needs.

 - BlueDAG is the only vendor to provide a comprehensive tool that integrates GPS data, effective pre-generated surveys for a variety of buildings and facilities and allows for the generation and management of a Title II management plan. While there are other tools that could accomplish components of this process, they either provide incomplete components or provide unwanted additional functionality
