## **FOURTH AMENDMENT TO AGREEMENT A-90-258**

THIS FOURTH AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered into this 7th day of vec, 2019, by and between COUNTY OF FRESNO, a Political Subdivision of the State of California, Fresno, California (hereinafter "FRESNO"), and COUNTY OF MADERA, a political subdivision of the State of California, whose address is 14215 Road 28, Madera, CA 93638 (hereinafter "MADERA").

## WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number A-90-258, dated 21st day of June, 1990 (hereinafter "Agreement"), pursuant to which FRESNO agreed to provide Emergency Medical Services Agency Administration to MADERA; and

WHEREAS, said AGREEMENT was amended on or about November 10, 1992, June 28, 1994, and April 13, 1999; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to modify compensation terms.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section D (COMPENSATION") of the Agreement, as amended, located on page 1, line 19 through page 2, line 13, of the Third Amendment to Agreement A-90-258, is deleted in its entirety and replaced with the following:

"Effective July 1, 2019, compensation paid by MADERA to FRESNO under this AGREEMENT for the provision of services hereunder shall be at a rate of FIFTY-THREE THOUSAND EIGHT HUNDRED SEVENTY FOUR DOLLARS AND 60/100 (\$53,874.60)"

COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the Agreement and, that upon execution of this Amendment, the Agreement and this Amendment together shall be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
