

1 RESOLUTION NO. 19-324

2 A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO DECLARING
3 ITS INTENTION TO LEVY AN ASSESSMENT UNDER THE UNIFORM STANDBY CHARGE
4 PROCEDURES ACT FOR LOCAL WATER AND SEWER UTILITY SYSTEM READY-TO-SERVE
5 OPERATIONS AND MAINTENANCE, UNDER CHAPTER 2 OF THE LANDSCAPING AND LIGHTING
6 ACT OF 1972 FOR STREET LIGHTING AND PUBLIC RIGHT-OF-WAY LANDSCAPE
7 MAINTENANCE, AND UNDER THE BENEFIT ASSESSMENT ACT OF 1982 FOR STORM DRAINAGE
8 AND ROAD MAINTENANCE, ALL FOR COUNTY SERVICE AREA 34, PROPOSED ZONE G
9 (GRANVILLE), APPOINTING AND DESIGNATING AN ASSESSMENT ENGINEER, AND DIRECTING
10 THE PREPARATION AND FILING OF AN ENGINEER'S REPORT

11 WHEREAS, Fresno County Ordinance Code sections 17.72.355 through 17.72.367 provide that
12 prior to the recordation of the final map of a subdivision containing any improved local public or private
13 roads, the subdivider shall have provided for their maintenance by a County Service Area or other
14 method acceptable to the Director of Public Works and Planning (Director), and that public sewers and
15 a community water supply system shall be provided to any divided parcels of thirty-six thousand square
16 feet or less that require the use of water and sewer systems; and

17 WHEREAS, the Board of Supervisors (Board) formed County Service Area No. 34 (CSA 34) in
18 1986 to provide a wide variety of governmental services for the community of Millerton New Town; and

19 WHEREAS, Tentative Tract Map No. 6189 (Tract 6189) lies wholly within the boundaries of
20 CSA 34; and

21 WHEREAS, to comply with a condition of approval of Tract 6189, a developer/landowner has
22 requested the formation of CSA 34, proposed Zone G (CSA 34G), also known as Granville; and

23 WHEREAS, for the reasons stated above, the formation of CSA 34G is proposed under Article 8
24 of the County Service Area Law and to that end the Board is also, by separate resolution today,
25 declaring its intention to form CSA 34G; and

26 WHEREAS, the County of Fresno (County) provides storm drainage and road maintenance,
27 lighting, open space and public right-of-way landscape maintenance and water and sewer services in
28 County Service Area No. 34 through zones established under Article 8 of the County Service Area Law
 (Government Code, sections 25217 through 25217.3), to include proposed Zone G of County Service
 Area No. 34 (CSA 34G); and

29 WHEREAS, the facilities and services proposed to be provided by the County in CSA 34G include:
30 (1) storm drainage and road maintenance, including street paving, striping, signage maintenance, repair

1 and reconditioning to maintain all of the in-tract and off-site streets constructed pursuant to the
2 development of Tract 6189, including the funding of special reserve funds created and funded as a
3 condition of approval for Tract 6189, and including inspection of street pavement to identify sections in
4 need of immediate repair, inspection of all street signage installed pursuant to the development of Tract
5 6189 and replacement as needed of any damaged or degraded street signs and poles, inspection and
6 reconditioning of all street striping, and all related insurance and administrative costs (collectively, Storm
7 Drainage and Road Maintenance); (2) paying for operations and maintenance of a street lighting system
8 owned by PG&E, providing street safety lighting along all of the Tract 6189 streets, to maintain the visual
9 presentation of those streets, and all work and expenses associated with the maintenance of the public
10 right-of-way landscaping, installed pursuant to the development of Tract 6189, to preserve the visual
11 presentation of the community (collectively, Lighting and Public Right-of-Way Landscape Maintenance);
12 and (3) maintaining water distribution piping system facilities and sewer collection piping and pumping
13 facilities in ready-to-serve status (collectively, Water and Sewer Facilities); and

14 WHEREAS, under Government Code, section 25217.1, subdivision (d), before the formation of
15 CSA 34G may be approved by the Board, user fees and benefit assessments to pay for the services
16 described above must be approved by owners of benefitted and specially benefitted properties as
17 required by Proposition 218 (California Constitution, Article XIII D, sections 4 and 6); and

18 WHEREAS, for the reasons stated above, the formation for CSA 34G is proposed under Article
19 8 of the County Service Area Law and to that end the Board is also, by separate resolution today,
20 declaring initiation of the proceedings to form CSA 34G; and

21 WHEREAS, Government Code, section 25215.6 authorizes the County to impose benefit
22 assessment in CSA 34G under the Uniform Standby Charge Procedures Act (Government Code, section
23 54984 through 54984.9) to pay for the costs of Water and Sewer Facilities; and

24 WHEREAS, Government Code, section 25215.3 authorizes the County to impose a benefit
25 assessment in CSA 34G under Chapter 2 of the Landscaping and Lighting Act of 1972 (Streets and
26 Highways Code, Division 15, Part 2, beginning with section 22500) to pay for the costs of the Lighting
27 and Public Right-of-Way Landscape Maintenance ; and

28

1 WHEREAS, Government Code, section 25215.3 authorizes the County to impose a benefit
2 assessment in CSA 34G under the Benefit Assessment Act of 1982 (Government Code, sections 54703
3 through 54720) to pay for the costs of Storm Drainage and Road maintenance; and

4 WHEREAS, CSA 34G, which is shown on by a boundary line on the map attached to this
5 resolution as Exhibit A-1, is the territory where benefit assessments to pay for the costs the Storm
6 Drainage and Road Maintenance, the Lighting and Public Right-of-Way Landscape Maintenance, and
7 the Water and Sewer Facilities, are proposed for imposition;

8 WHEREAS, for purposes of the benefit assessment for Lighting and Public Right-of-Way
9 Landscape Maintenance, the area to be assessed, which is CSA 34G in its entirety, the boundaries of
10 which are described in exhibit A, has been designated as "Granville Lighting and Public Right-of-Way
11 Landscape Maintenance District"; and

12 WHEREAS, Kheng Vang, a registered professional engineer, is designated as the assessment
13 engineer (Assessment Engineer), and an Engineer's Report under Article XIII D, section 4, of the
14 California Constitution and Government Code, section 54984.3 and 54717 is on file with the Clerk of the
15 Board;

16 WHEREAS, the proposed benefit assessment for the costs of the Water and Sewer Facilities is
17 based upon the Engineer's Report, including but not limited to sections 6 and 7 and exhibit F of that
18 report, which includes (1) a description of the service proposed to be financed through the revenue
19 derived from the assessment, (2) a description by Assessor's Parcel Number (APN) of each property
20 proposed to be assessed, (3) a description of the assessment and the method by which it will be imposed,
21 (4) a compilation of the amount of the assessment proposed for each parcel subject to the assessment,
22 (5) a statement of the methodology and rationale followed in determining the degree of benefit conferred
23 by the service for which the assessment is made, and (6) other factors required by Government Code,
24 section 54984.2; and

25 WHEREAS, the proposed benefit assessment for the costs of the Street Lighting and Public Right-
26 of-Way Landscape Maintenance is also based upon the Engineer's Report, including but not limited to
27 section 7 and exhibit H-1 of that report, which includes (1) a specification of the service proposed to be
28 financed through the revenue derived from the assessment, (2) an estimate of the costs of the Lighting,

1 and Public Right-of-Way Landscape Maintenance, (3) a diagram of Granville Lighting and Public Right-
2 of-Way Landscape Maintenance District, which is coextensive with CSA 34G, (4) a description by
3 Assessor's Parcel Number (APN) of each property proposed to be assessed, (5) a description of the
4 assessment and the method by which it will be imposed, (6) a compilation of the amount of the
5 assessment proposed for each parcel subject to the assessment, and (7) a statement of the methodology
6 and rationale followed in determining the degree of benefit conferred by the service for which the
7 assessment is made; and

8 WHEREAS, the proposed benefit assessment for the Storm Drainage and Road Maintenance is
9 also based upon the Engineer's Report, including but not limited to section 7 and exhibit H-1 of that
10 report, which includes (1) a description of the service proposed to be financed through the revenue
11 derived from the assessment, (2) a description by Assessor's Parcel Number (APN) of each property
12 proposed to be assessed, (3) a description of the assessment and the method by which it will be imposed,
13 (4) a compilation of the amount of the assessment proposed for each parcel subject to the assessment,
14 and (5) a statement of the methodology and rationale followed in determining the degree of benefit
15 conferred by the service for which the assessment is made; and

16 WHEREAS, Exhibit B to this resolution identifies all of the parcels that receive a special benefit
17 from the Water and Sewer Facilities, the Lighting and Public Right-of-Way Landscape Maintenance, and
18 the Storm Drainage and Road Maintenance services, upon which the benefit assessment is proposed for
19 imposition, and the amount of the assessment for each parcel;

20 NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF
21 FRESNO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

22 **Section 1.** The above recitals are all true and correct.

23 **Section 2.** The Board hereby declares its intention to proceed under the Uniform Standby
24 Charge Procedures Act and to levy and collect a benefit assessment in CSA 34G for the costs of the
25 Water and Sewer Facilities, to proceed under Chapter 2 of the Landscaping and Lighting Act of 1972 and
26 to levy and collect a benefit assessment in the Granville Lighting and Public Right-of-Way Landscape
27 Maintenance District (which is coextensive with CSA 34G) for the costs of the Lighting and Public Right-
28 of-Way Landscape Maintenance, and to proceed under the Benefit Assessment Act of 1982 and to levy

1 and collect a benefit assessment in CSA 34G for the costs of the Storm Drainage and Road Maintenance
2 in CSA 34G.

3 **Section 3.** Public protest hearings on each of the proposed assessments are hereby set for
4 **October 8, 2019 at 9:00 A.M., or as soon after as practicable, but in any case only after completion**
5 **of the public hearing on the proposed formation of CSA 34G, and only if there is no majority**
6 **protest in that formation proceeding,** in the Board Room of the Fresno County Board of Supervisors,
7 Room 301, Hall of Records, 2281 Tulare Street, Fresno, California, 93721, for hearing all objections and
8 protests to the proposed assessments as set forth in the Engineer's Report (collectively, Public Hearings).
9 The Public Hearings shall be held under Section 53753 of the California Government Code,. The Public
10 Hearings may be continued from time to time by the Board without further notice by the Board.

11 **Section 4.** The Board hereby authorizes and directs the Director of Public Works and
12 Planning (Director) or his designees, to prepare, separately for each of the three proposed benefit
13 assessments, the assessment ballots and assessment ballot instructions, any materials for the change,
14 withdrawal, or substitution of assessment ballots, including substitute assessment ballots and substitute
15 assessment ballot instructions, any materials for co-owner assessment ballots and co-owner assessment
16 ballots, and any other forms and materials, as the Director or his designees deem necessary or
17 appropriate, with respect to the submission of assessment ballots by record property owners of the
18 property within CSA 34G, under Section 53753 of the California Government Code,.

19 **Section 5.** The Board hereby authorizes and directs the Director or his designee to prepare,
20 for each of the three assessments, a notice of the Public Hearing (Notices). The Notices shall contain:

- 21 A. The dates, times, and locations of the Public Hearings;
- 22 B. The total amount of each proposed benefit assessment chargeable to all of the affected
23 parcels;
- 24 C. The amounts of the proposed benefit assessments for each affected parcel;
- 25 D. The basis upon which the amount of the proposed benefit assessments were calculated;
- 26 E. A statement that the amounts of the assessments will change in successive years through
27 Fiscal Year 2024-25 as stated in Exhibit B and the Engineer's Report, and then remain at the
28

- same amounts in the following years until any or all of the assessments is reduced or terminated, or there is a new proceeding to increase any or all of the assessments;
- F. The reason for each of the assessments, namely the costs of the Water and Sewer Facilities, the costs of the Lighting and Public Right-of-Way Landscape Maintenance, and the costs of the Storm Drainage and Road Maintenance;
- G. The address to which property owners may mail written protests against any or all of the proposed benefit assessments;
- H. The telephone number and address of an individual or office that interested persons may contact to receive additional information about the proposed benefit assessments;
- I. A separate assessment ballot for each of the proposed benefit assessments that includes the address for receipt of the ballot and a place where the person returning the ballot may indicate his or her name, a reasonable identification of the parcel, and his or her support or opposition to the proposed benefit assessment;
- J. Assessment ballot instructions as described in Section 4 of this resolution; and
- K. For each of the three proposed benefit assessments, a statement that the proposed benefit assessment shall not be imposed if the ballots submitted in opposition to the assessment exceed the ballots submitted in favor of the assessment, with ballots weighted according to the proportional financial obligation of the affected property.

The Director or his designee shall deliver the Notices to the Clerk of the Board no later than August 22, 2019.

Section 6. The Board hereby authorizes and directs the Clerk of the Board (Clerk) to sign and mail, no later than August 23, 2019, the Notices (which shall include assessment ballots and assessment ballot instructions as described above in Section 4 of this resolution), to the record property owners of the parcels to be assessed. On the face of the envelope in which each Notice is sent, there shall appear, in no smaller than 16-point bold type, the words "OFFICIAL BALLOT ENCLOSED." Upon the Clerk's completion of the mailing of the Notices, the Clerk is hereby directed to file with the Board an affidavit setting forth the time and manner of the compliance with the requirements of this resolution for mailing the Notices.

1 **Section 7.** The Board hereby authorizes and directs the Clerk to publish a notice of the filing
2 of the Engineer's Report and of the date, time, and place of the Public Hearing under Government Code,
3 section 6066, which is once a week for two successive weeks, with at least five days between each
4 publication, and to post copies of that notice in three places within the territory of the proposed CSA 34G.
5 The publication required under this section is for compliance with the Benefit Assessment Act of 1982,
6 specifically Government Code, section 54716, subdivision (c).

7 **Section 8.** If the Board imposes any or all of the proposed benefit assessments, the resolution
8 imposing each of the assessments shall provide that the amounts of the assessments will change in
9 successive years through Fiscal Year 2024-25 as stated in Exhibit B to this resolution, and Exhibit G to
10 the Engineer's Report, and then remain at the same amounts in the following years until either or both of
11 the assessments is reduced or terminated, or there is a new proceeding to increase any or all of the
12 assessments. If new, increased, or extended assessments are proposed, the Board will comply with the
13 notice, protest, and hearing procedures in Government Code, section 53753.

14 **Section 9.** The Board hereby finds and determines that it took all of the foregoing actions and
15 made all of the foregoing findings in full compliance with the law, including, without limitation, the Uniform
16 Standby Charge Procedures Act, the Benefit Assessment Act of 1982, the Landscaping and Lighting Act
17 of 1972, and Article XIII D of the State Constitution and any other law referred to in this resolution.

18 **Section 10.** The Director of Public Works and Planning and his designees, who may be any
19 employees of the County Department of Public Works and Planning that he appoints, are hereby
20 designated and authorized to tabulate the assessment ballots (including substitute assessment ballots
21 and co-owner assessment ballots) submitted, and not withdrawn, in support of or opposition to the
22 assessment referred to in this resolution. Each of those persons may, in their discretion appoint
23 assistants, including, but not limited to, any employees of the County Administrative Office, including
24 further any employees of the Office of the Clerk, to help tabulate the assessment ballots (including
25 substitute assessment ballots and co-owner assessment ballots). The Board hereby finds and determines
26 that each of the persons described in this Section 10 is an impartial person who does not have a vested
27 interest in the outcome of the assessment.

28 **Section 11.** This Resolution shall take effect immediately upon its adoption.

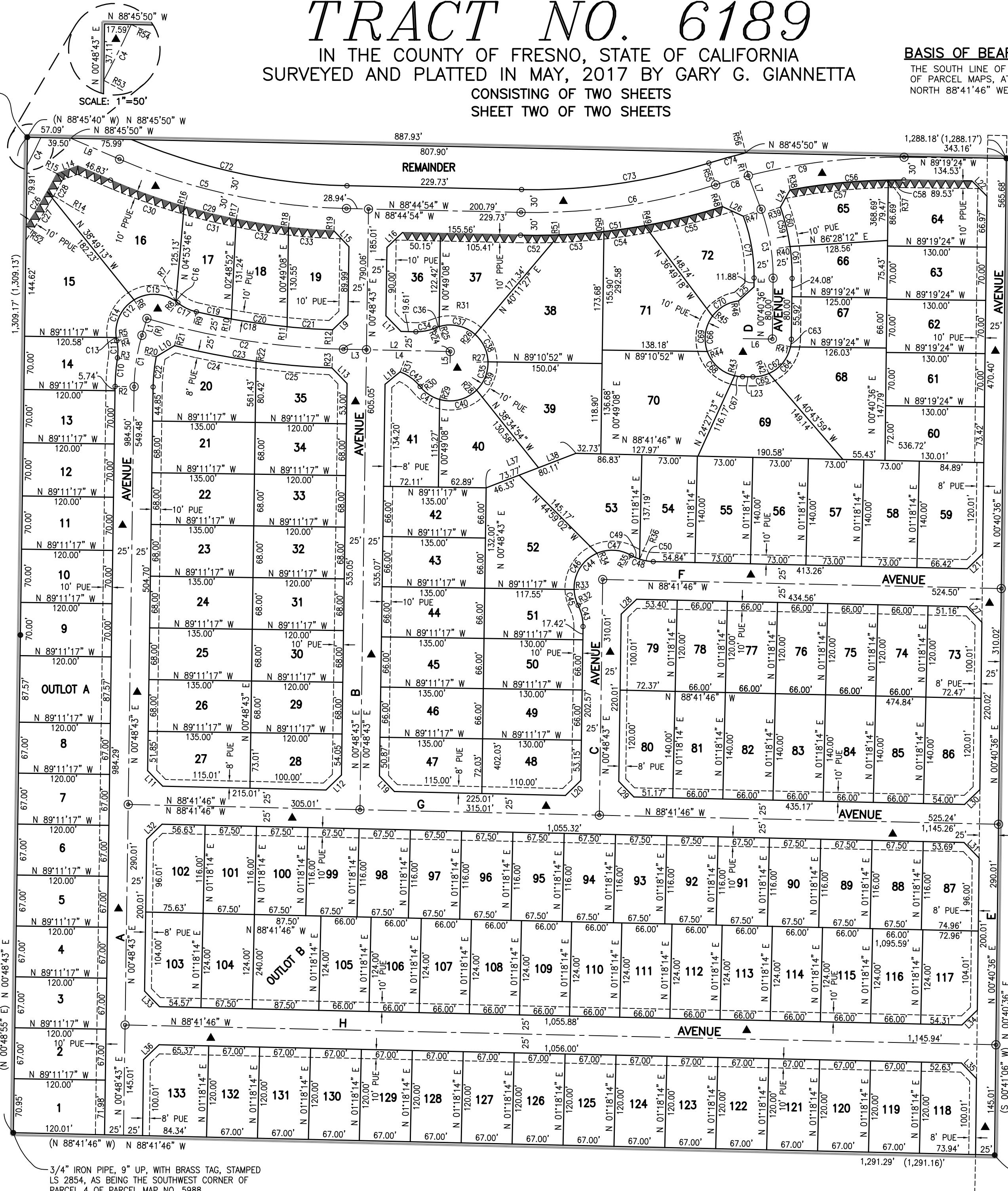
