The reason for the proposed boundary change is that in order to comply with a condition of approval for Tentative Parcel Map 8160 (which condition is required by Fresno County Ordinance Code section 17.72.358), a developer/landowner has requested a boundary change to include the two parcels described by Tentative Parcel Map 8160. The maintenance of the road within Zone "AJ" is provided by a benefit assessment levied on the properties within Zone "AJ." Under Government Code section 25217.4, subdivision (b, benefit assessments to pay for road maintenance services in CSA 35-AJ must be levied, assessed, and charged only within the boundaries of CSA 35-AJ. Under Proposition 218, a benefit assessment must be levied on all properties that receive a special benefit from the services to be funded by the benefit assessment.
