Abdulnasser Ali Dhalai 2444 S 9th St Fresno, CA 93725

I, Abdulnasser Ali Dhalai, owner of the business at 2444 S 9th St, Fresno, believe that me receiving a beer and wine license at my store would have a positive impact on the community and nearby residences and would not interfere with the quiet enjoyment of their properties or neighborhood. A convenience store should really be considered a necessity at or near this location. The closest store from here is about a 10 minute walk away, and many of the people here do not own cars.

Although we do need a beer and wine license to be profitable, most of the people will not be coming to our store for beer and wine. They will be coming for things like milk, eggs, bread, and other groceries. Our main focus will be on providing food and groceries to the neighborhood. So, as opposed to interfering with their quiet enjoyment, my store will become a benefit of living in the neighborhood. Secondary sources of income, like selling beer and wine or tobacco products, are so that we can survive as a business, as convenience stores without these things rarely become profitable businesses.

I understand that with any convenience store comes the possibility of criminal activity, as well as the possibility of underage drinking. I will do my absolute best to make sure that everything is done by the book. My family and I will be personally working the store to limit any potential issues with undertrained employees. We will ask for identification from anybody who wants to purchase alcohol to ensure that we are not selling to minors. We already have a security system, including an alarm and cameras, and we will be adding on to the system if we see a need for more cameras. We will not allow loitering in or around our store and I will personally make sure that anybody who is loitering will immediately be told to leave the area.

As we are on a corner lot, we have many street parking spaces (7-8), but we don't anticipate any issue with parking as most people will be walking here. This type of business does not generate much sound, as we will just have customers go in and out quickly to purchase goods. Our hours of operation will be 8am to 10pm, so they will not conflict with a regular schedule for a working person. We will receive all shipments between 9am to 3pm, and those would be the only activity that would make more noise, so they will not conflict with most peoples' work schedules. If we are able to obtain a beer and wine license, we anticipate a large boost in business, and would look to hiring some employees to help with the store. We would be hiring within the community.

Before we took over this business, this building was a magnet for crime. Now we have really helped clean up the neighborhood by opening our family-owned business that is intended to help the families in the area. We hope that we can continue to serve the neighborhood by getting our ABC beer and wine license, which we really will need in order to stay in business. Without this, we would not believe we would be profitable enough and would have to close our doors. Thank you for your time and consideration.
