WHEREAS, the County of Fresno will receive \$149,413 from Fresno Regional Workforce Development Board; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Public Defender Organization 2880; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Public Defender Organization 2880 as follows:




