RESOLUTION AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC WORKS AND PLANNING, OR THE DIRECTOR'S DESIGNEE, TO EXECUTE AND SUBMIT APPLICATIONS TO THE CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD TO UPDATE WASTE DISCHARGE REQUIREMENT PERMITS AND OBTAIN COVERAGE UNDER STATE WATER RESOURCES CONTROL BOARD ORDER WQ 2014-0153-DWQ FOR SPECIFIC COUNTY SERVICE AREAS AND COUNTY WATERWORKS DISTRICTS IDENTIFIED AND LISTED IN EXHIBIT A

WHEREAS, the State of California Regional Water Quality Control Board ("RWQCB"), under Water Code, Section 13263, subdivision (e), mandates periodic updates and amendments to existing wastewater discharge requirement ("WDR") permits; and

WHEREAS, the RWQCB provides a process to update WDR permits for small domestic systems with a monthly average flow rate of 100,000 gallons per day or less that discharge to land through coverage under State Water Resources Control Board Order WQ 2014-0153-DWQ, General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems ("General Order"); and

WHEREAS, the County-operated facilities in the County Service Areas and County Waterworks Districts identified and listed in Exhibit A ("Specified Facilities") are likely to qualify for coverage under the General Order and require updates, amendments, or both to their WDR permits; and

WHEREAS, the Board of Supervisors may authorize the Director of the Department of Public Works and Planning ("Director"), or the Director's designee, to execute and submit applications on behalf of the County of Fresno for coverage of the Specified Facilities under the General Order; and

WHEREAS, it is necessary to ensure the County of Fresno's timely action with respect to the updates, amendments, or both, to WDR permits in order to avoid compliance orders and fines from the RWQCB;

NOW, THEREFORE, IT IS RESOLVED that the Director of the Department of Public Works and Planning, or the Director's designee is hereby authorized to execute and submit applications to the RWQCB to apply for WDR coverage of the Specified Facilities under the General Order.
