WHEREAS, the District Attorney will receive \$408,286 from the Department of Public Health for the Waste Tire Enforcement Program; and

WHEREAS, of this amount, \$183,408 is not included in the adopted appropriations and estimated revenues of the District Attorney-Grants Org 2862 for FY 2019-20; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2019-20 appropriations of the District Attorney-Grants Org 2862 as follows:
