SECTION 100 - FOOTNOTES

N. Employees in the Security Officer II classification who are assigned by management to perform supervisory duties involving selecting, evaluating and disciplining subordinate staff shall receive an allowance of seventy-five dollars and no/100 (\$75.00) per pay period.

Persons designated by the department head to receive this allowance do so at the pleasure of the department head and assignment decisions designating or removing designation are not grievable or appealable to the Civil Service Commission, or subject to challenge in a court of law.

P. Employees in the classifications listed below who are placed on standby shall be compensated for the time on call at the rate of twenty dollars and no/100 (\$20.00) for eight (8), nine (9), or ten (10) hours, depending upon normal schedule, and for time actually worked as a result of call-back duty in compensatory time, or cash at the rate of one and one-half $(1\frac{1}{2})$ times the hours.

In instances when employees are authorized by management to phone off-duty employees at home, the employee receiving the call shall be compensated at time and one-half (11/2) for time actually spent on the call.

Employees called back to work who meet all criteria for use of private vehicles on County business shall be reimbursed for mileage driven to and from home at the current reimbursement rate.

Should the County call back any full-time employee in the classifications listed below after his/her normal working hours to perform work, the County shall compensate employee in cash or compensatory time off (where permissible under the provisions of the Fair Labor Standards Act) at one and one-half (1¹/₂) the hours worked for all hours actually worked, but in no event shall the employee receive less than a minimum of four (4) hours pay or compensatory time off, at time and one-half (11/2) regardless of time actually worked as a result of being called back to work to perform services for the County.
