### RESOLUTION NO. 19-382

#### A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO TO ESTABLISH THE SEWER SERVICE FEES FOR SEWER SERVICE PROVIDED THROUGH COUNTY SERVICE AREA NO. 34, ZONE G

WHEREAS, County staff initiated the process under California Constitution Article XIII D (Proposition 218) to establish sewer service fees for the 133 proposed residential lots that will receive sewer service through County Service Area No. 34, zone G (CSA 34G); and

WHEREAS, as part of that process, a notice of the proposed sewer service fee was mailed on August 20, 2019, to each record owner of property, as shown on the last equalized assessment roll, where residential sewer service through CSA 34G would be provided after subdivision into residential parcels under Tract Map No. 6189, and upon which the established sewer service fee was proposed for imposition at the time of the issuance of the building permit; and

WHEREAS, the notice mailed on August 21, 2019, described the amount of the proposed sewer service fees, the basis upon which the proposed sewer service fees were calculated, the reason for the proposed sewer service fees, and the date, time, and location of the public protest hearing on the proposed sewer service fees; and

WHEREAS, a public protest hearing was held on October 8, 2019, before the Board of Supervisors, at which time opportunity was provided for public comment, oral protests, and submission of written protests by owners of property where residential sewer service through CSA 34G would be provided after subdivision into residential parcels under Tract Map No. 6189, and upon which the sewer service fees was proposed; and

WHEREAS, the Clerk of the Board of Supervisors or her designee, at the end of the public protest hearing, tabulated the written protests received and determined that a majority of property owners as described above did not submit written protests to the proposed sewer service fees.

THEREFORE BE IT RESOLVED, based on the results of the protest hearing, there was no majority protest and the fees, as set forth in Exhibit A to this resolution, shall become effective November 1, 2019, with respect to each residential parcel created under Tract Map No. 6189 for which a building permit is issued, and shall be published in the Master Schedule of Fees, Charges and Recovered Costs for administrative purposes only.
