WHEREAS, the District Attorney- Grants Org 2862 will receive \$125,000 from the California Governor's Office of Emergency Services (Cal-OES) for the development and implementation of the Electronic Suspected Child Abuse Report System (ESCARS) Program and associated costs; and

WHEREAS, \$125,000 is not included in the appropriations and estimated revenues of the District Attorney- Grants Org 2862 for Fiscal Year 2019-20; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 District

Attorney- Grants Org 2862 as follows:


