## **AMENDMENT | TO AGREEMENT**

THIS AMENDMENT TO AGREEMENT ("Amendment") is made and entered into this 10th day of December, 2019 ("Effective Date"), by and between County of Fresno, a political subdivision of the State of California ("COUNTY"), and the Veterans Memorial Museum, a non-profit public benefit corporation, whose address is 2425 Fresno Street, Fresno, California 93721 ("CONTRACTOR").

## WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number 19-271, dated June 18, 2019 ("Agreement"), pursuant to which the COUNTY desired to honor Fresno County's veterans and preserve its military history through partially funding the CONTRACTOR; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to increase the Agreement maximum compensation amount for Fiscal Year 2019-20.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section five (5) of the Agreement, located on page three (3), lines nine (9) through 13, is deleted in its entirety, and replaced with the following:

"COMPENSATION/INVOICING: COUNTY agrees to pay CONTRACTOR, and CONTRACTOR agrees to receive compensation as follows: \$26,000 (twenty-six thousand dollars).

In no event shall compensation paid for services performed under this Agreement exceed \$26,000 during the term of this Agreement. It is understood that all expenses incidental to CONTRACTOR'S performance of services under this Agreement shall be borne by CONTRACTOR."

COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the Agreement, and that upon execution of this Amendment, the Agreement and this Amendment together shall be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
