WHEREAS, said monies were not included in the FY 2019-20 adopted appropriations and estimated revenues of the County Clerk-Elections Organization 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 County Clerk - Elections Organization 2850 as follows:
