

NOTICE is hereby given that at its regularly scheduled meeting on December 10, 2019, the Fresno County Board of Supervisors adopted Ordinance No. 19-024, an Ordinance of the County of Fresno, State of California
SUMMARY OF ORDINANCE

Amend the Ordinance Code of Fresno County by amending Title 11, Chapter 12, to add section 11.12.060 - snow removal conditions, which relate to the restrictions imposed on the parking or stopping of vehicles on certain highways and streets (or portions thereof) within the unincorporated area of the County of Fresno, and the placement of signs related to such restrictions.
