SUMMARY OF ORDINANCE

The proposed ordinance would amend multiple provisions of the Fresno County Ordinance Code, Title 15, Building and Construction, particularly Chapters 15.04 (General Provisions), 15.08 (Building Code), 15.10 (Fire Code), 15.12 (Mechanical Code), 15.14 (Energy Code), 15.16 (Electrical Code), 15.18 (Residential Code), 15.20 (Plumbing Code), 15.22 (Green Building Standards Code), 15.28 (Grading and Excavation), and 15.60 (State Responsibility Area Fire Safe Regulations of the County). The proposed ordinance would incorporate changes required by the 2019 California Building Code, published July 1, 2019 and effective January 1, 2020.
