IN THE AMOUNT OF \$280,000)

WHEREAS, the County of Fresno, Security Services, Organization (Org) 8970, requires an increase in appropriations in the amount of \$280,000 to allow for the payment of services and equipment related to the installation and programming of intrusion, fire and video surveillance systems necessary to meet departmental demands and use; and

WHEREAS, said additional costs will be financed by revenue from user County Departments benefiting from said alarm services in the amount of \$280,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2019-20 Security Services, Org 8970 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2019-20 Security Services, Org 8970 as follows:




