IN THE AMOUNT OF \$370,026 )

WHEREAS, the Security Services, Organization (Org) 8970, requires additional funds in the amount of \$370,026 to be used to fund the salaries and benefits and related services and supplies of eleven positions to include one Supervising Security Officer, one Senior Security Officer and nine Security Officers to address current contract obligations, fulfill requests of increased security services and effectively provide necessary services related to future County departmental moves; and

WHEREAS, the costs of said additional positions and related services and supplies will be fully funded by charge backs to other user County Departments benefiting from services provided in the amount of \$370,026; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2019-20 Security Services, Org 8970; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2019-20 Security Services, Org 8970 as follows:
