

THIRD AMENDMENT TO AGREEMENT

THIS THIRD AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered into this day of, 2020, by and between COUNTY OF FRESNO, a Political Subdivision of the State of California, Fresno, California (hereinafter "COUNTY"), and INTEGRATED VOTING SYSTEMS, INC., a Delaware Corporation, dba INTEGRATED VOTING SOLUTIONS, whose address is 496 S. Uruapan Way, Dinuba, CA 93618 (hereinafter "CONTRACTOR").

WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number 15-584, dated 17th November, 2015 (hereinafter "Agreement"), pursuant to which CONTRACTOR agreed to provide ballot printing, vote by mail processing, and vote by mail envelopes to COUNTY; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to extend the Agreement by 12 months in order to ensure continuity of services during a Presidential election cycle and increase the maximum compensation.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section 2 of the Agreement, located on page 2, lines 13 through 16, is deleted in its entirety and replaced with the following:

"This Agreement shall become effective November 18, 2015 and shall terminate on the 30th day of June 2021."

2. Section 4 of the Agreement, located on page 3, lines 19 through 25, is deleted in its entirety and replaced with the following:

"Five Hundred Forty-Five Thousand and No/100 Dollars (\$545,000.00) during the period of July 1, 2018 through June 30, 2019. In no event shall services performed under this Agreement be in excess of Eight Hundred Twenty Thousand and No/100 Dollars (\$820,000.00) during the period of July 1, 2019 through June 30, 2020. In no event shall services performed under this Agreement be in excess of Eight Hundred Thousand and No/100 Dollars (\$800,000.00) during the period of July 1, 2020 through June 30, 2021. in this Agreement from the period of November 18, 2015 through June 30, 2021, shall be Three Million Seven Hundred Thirty Thousand and No/100 Dollars (\$3,730,000.00). It is understood that all expenses incidental to CONTRACTOR's performance of services under this Agreement shall be borne by the CONTRACTOR."

COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the Agreement and, that upon execution of this Amendment, the Agreement and this Amendment together shall be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
