	Perspecta is our current hosting service and migrating off of the current environment would incur significant additional costs that are unneccesary.

The last time we migrated this system more than a dozen years ago, it incurred significant migration costs that are unneccessary for a system that the County is exploring replacements for this system.	
7.	Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.	
	The last time that we transitioned services over to Perspecta's servers, it took several dozens of man-hours from County employees. Any savings gained from bidding out the services would be more than offset by the additional costs of transferring the Property Tax system from one service to another, especially considering that the County is exploring options to get offf of this mainframe system alltogether, so the complete term may not be completed, further inflating the relative cost of a change.
