The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on March 24, 2020 at 9:00 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

The Ordinance to add Chapter 6.39, to Title 6 of the County of Fresno Ordinance Code (the "Ordinance Amendment") to regulate the practice of massage therapy and the operation of massage establishments, to protect the public health, safety, and welfare, to prevent blighting conditions, and discourage prostitution/human trafficking and related illegal activities carried on under the guise of massage therapy, and establish certain sanitation, health and operational standards for massage establishments.
